## Dear Member

I finished my last letter by hoping that I would be able to write with better news before Christmas; there is particularly good news about the development and trials of the vaccine and much publicity has been given to 3 vaccines that seem to have completed highly effective advance trials.

Last week it was announced that the Government had referred 2 vaccines to the MHRA (The Medicines and Healthcare products Regulatory Agency). If these vaccines are authorised then the government expects that the vaccine will be rolled out from December but realistically the bulk of the rollout will be in the early part of 2021. The Prime Minister very much hopes that by Easter the majority of adults will have been offered the vaccine.

This certainly now gives us the opportunity of beginning to plan for branches to start meetings and other activities early summer 2021 although we would still need to remain cautious.

The vaccination programme will be a huge logistical challenge and it would appear that in addition to vaccinations taking place in GP surgeries and local community centres there will be 30 or 40 mass vaccination centres opened up throughout the country. I know a number of you have volunteered to help with the vaccination programme and although the details are far from clear at present it would seem the best way to volunteer would be to approach your local NHS Trust many of which are currently advertising for help. A cautionary note though some if not all are not engaging people over 70.

If you are successful in becoming a volunteer we would very much like to hear about your experience.

In England from just after midnight on 2<sup>nd</sup> December the majority of the country will be in Tier 2 high and Tier 3 very high with surprisingly only 2 areas of the country in Tier 1 medium. The tiering arrangements are to be reviewed fortnightly but realistically there will not be any significant changes before the new year.
