Dear Member

What a year!

It was 31st January 2020 when the first 2 cases of coronavirus were diagnosed in a York hotel. We could not have possibly imagined the impact this virus would have and even when the first lockdown started on 23rd March 2020 we were all hopeful of some sort of normality by the summer. This has proved to have been very wishful thinking and with the latest lockdown in place now (albeit slightly different in England, Scotland and Wales) it is clear that there is uncertainty as to when the regulations will be relaxed. Matt Hancock said over the weekend that the easing of lockdown restrictions was a long,

long way off.

The good news is the vaccination programme is now well under way with over 6 million already vaccinated and the likelihood that by the end of February most of the vulnerable groups including those over 70 will have had their first vaccination. So there is light at the end of the tunnel but it remains a very long tunnel.

The impact of this on the Fellowship remains huge and it seems unlikely that branches will be able to meet before July or even September. However we do have to make some planning decisions and we are still very optimistic that our Conference and AGM will be able to go ahead in Manchester on the 22nd October 2021. Another decision we have had to take means that the major recruitment drive planned for April/May 2021 can no longer go ahead and it is clear from the returns we have had from the branches so far that our membership figures are reducing.

As I have mentioned in previous letters we very much hope that you continue with your membership even though branches are not meeting. If you have not been able to pay your capitation fee to your branch due to current restrictions or for any other reason

please contact central office for guidance.

We continue to be delighted with the positive comments received from our members about the contact from the Fellowship. I will continue to send you my monthly letter but I am very open to suggestions from you if there are topics you would like me to refer to. Remember the staff and I are happy to talk to you and the central office telephone is monitored daily.
